Final Settlement	In respect of final settlement, the Floating Price will be a price in USD and cents per metric tonne based on the average of the "\$/mt" assessments appearing in the "Platts Dirty Tankerwire" under the heading "Americas Dirty Tankers", subheading "Aframax" for the Vancouver to China route for each business day (as specified below) in the determination period.
