Final Settlement	In respect of final settlement, the Floating Price will be a price in USD and cents per metric tonne based on the difference between the average of the "Mid" quotations appearing in the "Platts European Marketscan" under the heading "Mediterranean cargoes" subheading "FOB Med (Italy)" for "Prem Unl 10ppm" and the average of the assessments as made public by General Index for "Eurobob Oxy Gasoline NWE FOB Barges" for each business day (as specified below) in the determination period. Non-Common Pricing applies.
