- **Precision exposure to tech leaders** – choose broad tech index exposure or targeted single stock exposure

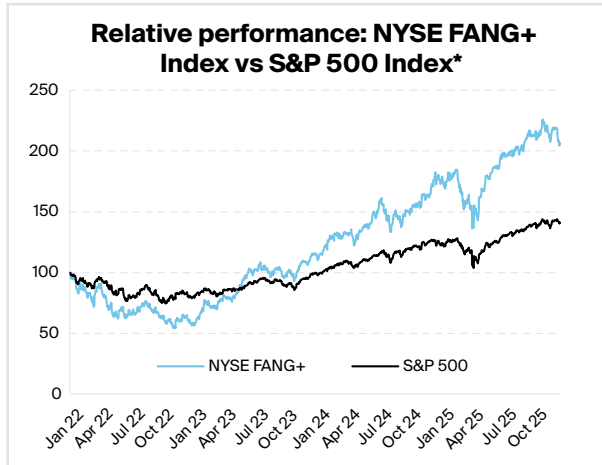


Mini NYSE FANG+ Index futures & options

The NYSE FANG+ Index tracks 10 highly-traded growth stocks from leading technology and tech-enabled companies.

The NYSE FANG+ Index constituents are equally weighted and regularly rebalanced to prevent over-concentration in any single stock, maintaining diversified exposure within the technology sector.

- Track the index price directly with \$1 USD per point
- 2 quarterly expiries are available (March, June, Sept. and Dec.)
- Trading from 01:00 – 21:00 U.K. time
- Expiry price based on NYSE FANG+ Index opening level on the last trading day

Mini NYSE FANG+ Index options

- Used for protection or volatility
- Provides ability to act only when it benefits you, with no obligation to exercise
- Daily expiries Monday to Friday up to a year
- European style, cash settled
- Trading from 08:00 – 17:30 U.K. time
- Expiry price based on NYSE FANG+ index opening level on the last trading day

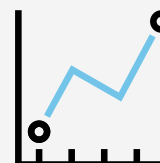
Mini U.S. Stock futures & options

Mini U.S. Stock futures and options are listed on a selected list of **20 U.S. companies**, containing headline technology leaders and the companies driving the next generation of innovation.

These contracts are designed to give investors flexible and capital-efficient exposure without having to trade large notional positions. They feature a standardized size of 100 shares and offer flexible styles, maturities, and option strikes.

- **Hedge earnings or event risk** on a single stock
- **Express a targeted market view** without owning the shares
- **Diversify portfolio** more precisely
